The strip reminds me of THE PERRY BIBLE FELLOWSHIP, except all of the settings of F-MINUS are reality-based (many PERRY BIBLE FELLOWSHIP strips were set in fantasy worlds). Also, each strip is only one panel. F-MINUS is a very funny strip and THIS CAN'T BE LEGAL is a great collection. Highly recommended for people who enjoy great comic strips.

If you're a fan of The Far Side and miss it as much as I do, you'll find the same twisted sense of humor in Tony Carrillo's strip. Maybe Tony is actually Gary Larson incognito? F Minus is consistently hilarious. Tony Carrillo's humor cuts deep...sometimes his work is painfully funny.
