

In 1998, within fifty hours of Porterâ ™s scheduled execution, the Illinois Supreme Court granted a stay, pending a hearing on Porterâ ™s mental competency. Soon, Porter was released from prison, and Alstory Simon, then a Milwaukee resident, was convicted of the Washington Park homicides. But thatâ ™s not the end of the story. Nor is it all of the story. Simon himself has now been exonerated and is suing Northwestern University, David Protess, and two other individuals for more than \$40 million in punitive damages. This is the true story of how and why Alstory Simon replaced Anthony Porter in prison.
