

I especially appreciate how this book anticipates what readers might ask as they read the provided lessons. The authors of this book have used different font colors to indicate main topics, subtopics, and cases that demonstrate what they teach throughout this book. The only downside to this book, for me, which I managed to get over was while reading this book was that the book started off with an emphasis on law that was unexpected and familiar to me, then seemed to quickly move to subjects like corporations, partnerships, and related topics.
